In 2021, 5,744 animals found homes, including 5,317 adoptions, 73 animals returned to their owners, and 354 transferred to other shelters for adoptions.

Fern Creek and Eastpoint Pet Resorts - boarding, grooming and day care of owned pets. Proceeds from operations support the mission of KHS and care for companion animals.

S.N.I.P Clinic --- Affordable spay/neuter surgeries for dogs and cats serving Louisville and the surrounding counties. High-quality, high volume surgeries designed to reduce the pet overpopulations. The SNIP Clinic performed 8,541 spat/neuter sugeries in FY21, with 2,969 of these procedures either free or discounted.
