KHS is Kentucky's largest animal adoption agency, finding loving homes for 6,133 animals in 2022. This includes 5,857 cats, dogs and horses who were adopted at our Main Campus, East Campus, Willow Hope Farm and our adoption partner Purrfect Day Cafe. Another 275 animals found homes through transfer partners.

Fern Creek and Eastpoint Pet Resorts - boarding, grooming and day care of owned pets. Proceeds from operations support the mission of KHS and care for companion animals.

4c (Code:) (Expenses \$ **1,696,513** including grants of \$) (Revenue \$ **738,129**)

Our S.N.I.P. Clinic provides high-quality, low-cost spay/neuter surgeries to reduce the number of animals in shelters and remove financial barriers that may prevent caring pet owners from spaying or neutering their pet. In 2022, the S.N.I.P. Clinic performed 9,166 surgeries, 26% of which were free or discounted, including free surgeries for Pit Bulls to help address the breeds overpopulation.
